

Annual Rogers Family Tourism Award

Definitions and Selection Criteria 2019

The San Marcos Convention and Visitor Bureau (SMCVB) will present two awards in recognition of individuals who have made significant and outstanding contributions to the tourism industry in San Marcos, Texas. The awards will be presented during the National Travel and Tourism Week Reception to be held Wednesday, May 8. Nominees are solicited from any person who wishes to submit the requested information of an eligible recipient on the appropriate form by the deadline – Thursday, April 11, 2019.

The **Rogers Family Tourism Award** is presented to an individual in recognition of major and lasting contributions to the promotion of San Marcos tourism, or dedication to and development of the San Marcos tourism industry.

Definition: Presented to an individual who has done the most to develop or further the growth of tourism in San Marcos in the last decade.

The **Rogers Family Tourism Lifetime Achievement Award** is presented to an individual in recognition of pioneering or groundbreaking efforts in developing tourism in San Marcos or dedication to and development of the San Marcos tourism industry.

Definition: Presented to an individual who has made outstanding lifetime contributions to develop or further the growth of tourism in San Marcos since 1928.

RULES & REGULATIONS

1. Nomination Selection Criteria must be met. See below for criteria.
2. Photocopy this form if you wish to make more than one nomination.
3. You may nominate yourself, co-worker, volunteer in your organization, etc.
4. An award committee representing the SMCVB will select winner.
5. Nomination forms and supporting materials will not be returned.
6. Winners will be announced at the National Tourism Week Reception.

SELECTION CRITERIA

The Award Committee will make its selection based upon the following criteria:

1. Individuals, Couples, Families, and organizations can be considered for this award. Businesses are not eligible.
2. Past recipients of the award are not eligible to receive the award again. Complete list of past recipients: www.toursanmarcos.com/about
3. Individuals may be volunteers, employees, management or owners of a tourism-related organization or business.
4. Recipients must have performed their exemplary service to the promotion and/or development of tourism in the San Marcos.
5. Recipients' service should be far above that which would normally be expected in the course of their job or elected duties.
6. *Rogers Family Tourism Award:* only contributions or service performed in the last decade will be considered.
7. *Lifetime Achievement Award:* contributions benefiting tourism at the local, regional or state levels can span back as far as 1928.
